The Basics

2020 HMIS Data Standards were released in May 2019, with an effective date of Oct. 1, 2019 for all changes except:

 Coordinated Entry Data Element 4.20 – Coordinated Entry Event ("go-live" date of April 1, 2020)

 All changes have been implemented in Clarity Human Services

HMIS Data Standards:

What are the HUD HMIS Data Standards?

- HUD mandated data collection required for HMIS
- Changes occur each year, sometimes minor, sometimes more impactful
- Depending on what your role is where you work, some elements may or may not impact your work
- Data Element numbers can be used to reference elsewhere for more resources

HMIS Data Standards: Key Terms

- Enrollment/Entry Screen required federal data collection fields such as prior living situation, move-in date
- Services tracks date/type of service e.g., bed night, contacts
- Assessments Status
 Update/Annual/Current Living Situation
- Exit Screen end date, destination, other required fields

HMIS Data Standards: All Programs **Universal Data Elements:** Elements required to be collected by all projects participating in HMIS, regardless of funding source.

Changes:

- 3.08 Disabling Condition
- 3.20 Housing Move-In Date (PH/RRH)
- 3.12 Destination
- 3.917 Prior Living Situation

HMIS Data Standards: All Programs

3.08 Disabling Condition Disabling Condition (yes/no) will no longer appear on Status/Annual or Exit Screens

The specific disabling condition questions will remain on the other screens, so user workflow will remain the same for those elements.

4.06 Developmental Disability 4.08 HIV-AIDS

Removed dependent element "Substantially impedes the individual's ability to live independently"

HMIS Data Standards: Housing Programs (PH/RRH)

3.20 Housing Move-in Date

Now only collected at Entry (not available on screens other than enrollment)

COMPLETE HOUSING MOVE-IN DATE WHEN CLIENT MOVES INTO A PERMANENT HOUSING UNIT

4.12 Current Living Situation

Drop-down lists of living situations are now all in alignment

Three new options: Host Home Rental by client, with HCV voucher (tenant or project based) Rental by client in a public housing unit

Interim Housing has been retired



HMIS Data Standards: All Programs

Updated wording in places

Previous Value	Current (2020) Value

4.11 Domestic Violence

- Collection now required for PATH and SSVF programs
- Has been removed from 2020 Exit Screens

HMIS Data Standards: Current Living Situation (NEW)

 Outreach Contacts are now known and recorded as Current Living Situations

In Clarity, moved from Services tab to the Assessments tab HMIS Data Standards: Street Outreach, nbn Shelters, Services only (Coord Entry)

4.12 Current Living Situation

- Replaces Outreach Contact Service
- Picklist matches Prior Living Situation and Destination
- Is an assessment; data will cascade (populate) from previous entry
- All contacts were mapped over to CLS in assessment section
- Designed to capture information on where a person is staying at a point in time



HMIS Data Standards: Coord Entry 4.19 Coordinated Entry Assessment

Collects an assessment date, location, and assessment results

Cambridge CAN's new assessment (not yet live) includes these elements

Coordinated Entry Assessment:

Fields and Dependents

- Date of assessment
- Assessment location
- Assessment Type
- Assessment Level
- Assessment questions (both questions and answers determined locally)
 - Assessment answers
- Assessment Result Type
 - Assessment Result
- Prioritization Status

HMIS Data Standards: Coord Entry

4.20 Coordinated Entry Event

- Capture access and referral events, as well as the results of those events
- Help communities understand the events that go into achieving desired (and undesired) results through the CE system
- Will go live in April 2020
